



EXECUTIVE DIRECTOR'S MESSAGE

The year was another of great success for PLEA. Ongoing major projects continued, and exciting new projects began. We had hoped for approval of more new projects than were awarded after a flurry of proposals in the summer, but at the same time see this as opening doors for other opportunities and approaches. In any event, there is no question we will continue to work at full capacity to always add to and improve the PLEI (public legal education and information) we are producing for Saskatchewanians.

In Teachers & Schools programming, presentations for schools, delivered by our partner-students of Pro Bono Students Canada University of Saskatchewan Branch, continued on as they have now for over ten years. These provide invaluable information for young people on Consent and the Law, Cyberbullying, and on Becoming a Lawyer. Issues of the ever popular *The PLEA* newsletter support all of these presentation titles. Also, the newsletter title Running Jokes was released around provincial election time, as was our extremely popular and valued Our Government Our Election learning resource.

We still found in 2024, as we expect to always, that printed materials remain very important to the public. Certain of our titles are most appropriate for people to have in hand in the form of booklets and pamphlets. These include *Renting a Home, A Death in the Family*, and *Wills and Estates*.

Many years' supplies of these three publications were printed in 2024.

The year saw the end of our involvement with the landmark *Listen* program and we were very pleased to be able to pass the torch to the Elizabeth Fry Society who assumed its operation. Much work was done to transfer the required digital infrastructure, lawver roster, and other components to help them house this vital service within their agency. Shift's funding expired at the end of March but we were very pleased when the federal government, the next month, renewed funding for similar project work. We were very grateful to receive funding for the revival of the *Shift* program for Saskatchewan. Listen, through Elizabeth Fry, and Shift from PLEA will continue to provide extremely valuable direct legal services to survivors of sexual violence or harassment by matching them with lawyers for up to four hours of free legal advice or information.

The project Improving Access to Justice for Indigenous Communities completed its third year in 2024 and will wrap up early in 2026. Consultations with Indigenous communities and individuals are complete and development of specialized PLEI resources for Indigenous communities in print, online, through videos, and for schools is underway.

PLEA was active in the work and discussions of provincial A2J (Access to Justice) working groups, forums, and committees, Much

is always learned and shared at these tables. Talks in 2024 included the genesis for the launch of Saskatchewan's first ever youth legal literacy needs assessment, and a guide for the public on responsible and effective use of artificial intelligence when looking for answers to legal concerns. We saw over the year, and expect it will be the case for many years to come, much talk of Al and the field of PLEI.

The first half of the Law Foundation-funded two-year project Comprehensive Review and Update—PLEA Resources was completed. All online material in PLEA's vast library of resources was reviewed and updated, and attention for the second year will be on print resources.

There is always many to thank for our success. First and foremost are the Law Foundation of Saskatchewan and the Department of Justice Canada. Next comes PLEA's board of Directors, and PLEA's extraordinarily talented and dedicated staff. We were extremely happy to add to the team our new Manager of Administration and Office Operations, Tanya Clarke, and Accountant Marshall Henley, CPA. Both have fit in seamlessly in every respect. Lastly, it will never change that we are most thankful of all for the support of the people of Saskatchewan.



In a liberal democracy, the right to run for office is just as important as the right to vote. This principle guides Running Jokes, an issue of The PLEA

newsletter that examines people who put their name on the ballot not to win but rather to satirically challenge the status quo.

From Pat Paulsen, the first person to fuse a satirical run for office to a national television show, to Hugh Arscott, Saskatoon's civic-minded local who purposely set out to lose a federal election, to Boston Curtis, the first mule elected to public office, Running Jokes uses the stories of unusual candidates to help us think about elections and the ways that we govern ourselves.

The Cam Partridge Memorial PLEA Volunteer of the Year Award recipient for 2024 is Brent Toles, curriculum consultant with the Saskatchewan Ministry of Education.

If you're familiar with the credits pages of PLEA's Teachers and Schools resources, you're familiar with the name Brent Toles. Brent has reviewed countless PLEA learning resources to help ensure that our educational materials intersect with the curricular goals and the broader policy objectives of Saskatchewan's Ministry of Education.
